MATCH 9 STAGE 1 BUTLER

6H by N/S is a good slam but not many pairs reached it.

West opened 1D and North doubled. Many South's leapt to 4H and played it there.

In hindsight it is easy to construct auction that gets you to 6H

I like a cue bid of 2D by South, then over 2H a 4D Splinter (Heart Happiness) expressing Slam interest which should be enough for North to check for Aces and go to 6H.

If North prefers to cue 4S over 4D, South can "re-cue" the DA or even just bash 6H'

A TESTING 3NT

MATCH 10 STAGE 1 BD 15

3NT on this board by West was a popular contract in both the OPEN + WOMENS

A low heart to the Ace and a heart return puts West and North under the spotlight.

At some tables, North had overcalled in hearts. As the cards lie, if

declarer plays four rounds of diamonds, North is squeezed. North's best shot is to bare the SK smoothly. Now declarer might play on clubs and North will win the queen and cash hearts for down one.

If North agonises over the second spade discard an alert West may guess the SK is now bare. And of course if North discards two hearts on the fourth round of diamonds, declarer is Home Free losing 3Hearts and the CQ.

Action in the Open

by Paul Yovitch

Hoping for a little excitement, I sat down and watched the round 7 match between two of the leading pairs in stage 1 of the Open Butler trials. Michael and Margaret Courtney against Kim Morrison and Marilyn Chadwick. I was not disappointed.

In top level Open Bridge, everyone loves to bid, and both those pairs are known for their ultra-aggression. Here are some of the opening bids I saw in this match:

Board 17: A1063, Q83, QJ73, J9 Michael Courtney opened 1S in third seat.

Board 18: J9872, 5, AK83, J43 Morrison opened 1S in third seat.

Board 19: 3, 84, QJ10, KJ87653 Michael Courtney opened 4C in first seat, albeit at favourable vulnerability.

Board 22: K105, K54, J654, KJ Michael Courtney (stop me if you have heard this one before) opened 1S in second seat.

On the other four boards someone had a "normal" opening bid!

The most interesting thing about these boards is that the side which opened gained IMPS every time. On 17, the Courtneys forced Morrison-Chadwick to the four level: one off in 4C was 3 IMPS out. On 18, the Courtneys ended in a 4-3 heart fit, and went one off in 2H after trumps broke 5-1 (3 IMPS back). On 19 Morrison – Chadwick missed a tight - but making - slam, losing 2 IMPS but missing the chance to gain 12. And on 22 the Courtneys reached a tight 4S, which earned 4 IMPS with a fair part of the field not bidding game but the match's biggest swing came from a defensive lapse:

The Courtneys reached 4S, and Morrison led CA followed by DA. Michael ruffed, and then led a spade to the ten and queen, giving Chadwick the chance to give Morrison a club ruff. However, she returned a diamond, and Courtney wrapped up 10 tricks (8 IMPS instead of 9 away) and the match to the Courtneys by 21 IMPS.

Ed. Paul Yovich is one of W.A.'s top players and he is not contesting the Butler Trials this year but kindly wrote this article in response to our pleadings for contributions.

Sathi Moses (who lives in Perth) played 3NT from the North chair after East had opened 1S, (South X, N 1NT, S 3NT).

East led the C2. Sathi cashed A, K, Q clubs on which East pitched a heart and a spade.

Next came A and Q hearts (West showing out). Sathi considered the bidding and deduced that East probably had the actual hand dealt. So she cashed AD and exited D.

East exited a heart into the K10. Sathi now exited S10 to east's J.

Now East had to give declarer a spade trick. +400 was worth +10 IMPS to Sathi Moses and Pauline Hammond.

Note that if East leads SQ initially, if North plays carefully ie wins KS, DA at trick2 then 3 top clubs, then A and Q hearts, then spade to the 10 endplays East.

This board generated some interesting results.

In one match Margaret Bourke opened 1NT (12 - 14) and Lydia Beech knew that if she passed, a double by South was very likely. So she took "Text Book " Action by bidding 2 Clubs Stayman. South doubled showing clubs and soon after the final contract became 2H X.

In the event the defence was not optimal and down one was the final result .

In another match West opened one club and when this came round to South (Sathi Moses) she wisely passed. In the fullness of time the defence made twelve tricks for +600

It's not often you see the defence make a small slam. If South is declarer in Clubs there are only eleven tricks.

As the cards lie, both 3NT and 4 Spades by N/S are making.
